**ORGANIZATION AND INDIVIDUAL MEMBERSHIP PROCEDURE**

Individuals or organizations wishing to become members of the V.R.C. must fill out an "Application for Membership" form which will be given consideration by the Board. The applicant will continue to have non-member status until the application is approved. Once a decision has been made prospective members will be contacted and informed of the Board's approval. A bill for membership fees will then be issued to the member. Member groups may obtain a key and security code for the building. (\$8/key)
